MONTANA'S UPDATE ON ITS SETTLEMENT OFFER TO WYOMING

1. On August 11, 2016, Montana filed Montana's Notice of Settlement Offer, notifying the Special Master that Montana had made a confidential offer of settlement to Wyoming for Montana's damages claim stemming from Wyoming's violation of the Yellowstone River Compact in 2004 and 2006.

 Montana had requested that Wyoming respond to Montana's settlement offer by August 22, 2016.

3. Wyoming did not respond to Montana by August 22, 2016, nor has any response from Wyoming been received by Montana as of today's date.

4. As a result, Montana's settlement offer did not result in a resolution of any part of the case.
