The State of Wyoming presents the following Status Report No. 16 pursuant to Section VII.D. of Case Management Plan No.1:

1. On April 12, 2013, Montana filed Objections to Wyoming's Expert Designation and Expedited Motion for Supplemental Depositions.

2. On April 15, 2013, Montana filed Errata Notice for Pages 15 and 16 to Montana's Objections to Wyoming's Expert Designation and Expedited Motion for Supplemental Depositions.

3. On April 17, 2013, Wyoming filed a Response to Montana's Objections to Wyoming's Expert Designation.

4. On April 18, 2013 Montana filed a Reply in Support of Montana's Objections to Wyoming's Expert Designation and Expedited Motion for Supplemental Depositions.

5. On April 18, 2013, the Special Master held a hearing on Montana's Objections to Wyoming's Expert Designation and Expedited Motion for Supplemental Depositions.

6. On April 23, 2013, the Special Master filed an Order Regarding Expert Witness Designation.

7. On April 23, 2013, Wyoming served a letter on Montana regarding Montana's deficient responses to Wyoming's Second Request for Admissions, Second Request for Production and Third Set of Interrogatories. Wyoming specifically identified the deficiencies, and asked that Montana address Wyoming's concerns by May 7, 2013. If Montana fails to satisfactorily address the identified concerns, Wyoming intends to seek resolution of the deficiencies by the Special Master.

8. On April 24, 2013, Montana deposed Wyoming's designated expert witness, Doyl Fritz.

9. On April 25, 2013, Montana deposed Wyoming's designated expert witness, Bern Hinckley.


10. On May 1, 2013, Wyoming provided Montana additional information Montana had requested during the deposition of Doyl Fritz.
