For the purpose of issuing the DS-2019, Stanford University has designated that support of over 50% by personal or family income (including bank loans or loans from friends) would disqualify a student from the issuance of an DS-2019. *Note:* Company funding is permitted for issuance of

the J-1 visa as long as personal or family funding does NOT exceed 50% of the total yearly budget for each year the student attends school. For example, a student admitted to a two-year master's program who shows 100% company funding for the first year and 100% personal or family funding for the second year does NOT qualify for the J-1 visa.
