The following are definitions of title designations:

Regular staff – A benefits eligible employee who works at least 50% FTE for at least six consecutive months (four months for bargaining unit employees).

Tenured Faculty – Tenure line faculty who have received a permanent academic appointment.

Junior Faculty – Full-time Assistant and Associate professors, in the tenure line who have not been received tenure, non-tenure line, and Medical center-lines

Student – Matriculated Stanford University students

Child Care Services Eligibility Matrix

Post-Docs – Non-matriculated post-doctoral graduate students

Clinical educators - Clinician/Educators are exempt regular staff members appointed for fixed terms of up to five years, which terms may be renewed.

Lecturers, coaches - Academic Staff-Teaching

Resident – non-matriculated clinical post-graduate in training

SUH/LPCH staff – employees of Stanford University Hospital or Lucile Packard Children's Hospital (a separately incorporated entity)

Carnegie/ Hughes Medical – institute employees (long term affiliation with SU)

HighWire Press – Stanford University staff

Visiting Faculty/Scholars – employees of other institutions – not eligible for Stanford University Health and Welfare benefits
